AMENDMENT TO BYLAWS OF MAISON DE VILLE, A CONDOMINIUM PROJECT

The State of Texas I

This is to certify that the Bylaws of Maison de Ville, a condominium regime in Harris County, Texas, originally recorded in Volume 15, Page One of the Condomin Records of Harris County, Texas, were amended at a meeting of the Co-Owners duly called and held on the 20th of May 1987, to read as follows, to-wit:

Article IV, paragraph 1, is amended to read: (changes underlined)

- The officers of Southwest Condominium Corporation shall be the Board of Administration until May 1, 1974 and thereafter until a Board of Administration is duly elected by the Council, after which the affairs of the Council shall be governed by a Board of Administration (sometimes herein referred to as the Board) composed of five persons, all of whom must be owners of an apartment in the Condominium project but do not have to reside in their units in order to qualify to serve as Board members. The Council may increase the number of members of the Board of Administration and fix their qualifications by Amendment to the Bylaws.




